WestJet Service:

- Currently serves Toronto (YYZ) 3x weekly; Calgary (YYC) 4x weekly
- May 19, 2023: Service to Vancouver, 2x weekly to start

Proposed Incentive / Letter of Agreement (LOA) Terms:

- Term: 2 years from start of service (May 19, 2023 May 18, 2025)
- Total estimated incentive value based on actual flight activity
 - 2 flights/week = \$168,300
 - 7 flights/week \$339,000 Mid-range \$254,000

FY23 Amended O&M Budgets – BNA and JWN

- On April 12, 2023, the Finance Committee reviewed in detail, and recommended approval of the 2 budgets by vote of 3 to 0.
- BNA adjustments driven by new enplanement forecast for FY23 (10.3M 10.8M enplanements)
- Key changes to FY23 BNA O&M Budget
 - Increased parking revenue
 - Increased parking lot operations, shuttle bus services, credit card and utilities expenses
 - Increased Passenger Facility Charges (PFCs) and use of Federal Relief Grants
- Key changes to FY23 JWN O&M Budget
 - Increased hangar rents, reimbursable services and fuel flowage fees
 - Increased janitorial services, electrical supplies and utilities expenses
 - Increased use of Federal Relief Grants

AULA Key Business Terms

- Term: 8 years (FY24-FY31), with one 2-year mutual option
- Minimum Signatory Airline Commitment: Passenger 1% rates/charges/fees; Cargo 1% landing fees
- Methodology: Landing Fee Residual; Terminal Rate Commercial Compensatory
- Satellite Concourse Terminal Rate: 2.5% discount
- **Debt Service Coverage:** Rolling in all rate calculations for airline cost centers
- **Revenue Sharing:** In-terminal concessions, based on weighting of net remaining revenue, in-terminal concessions and amount per enplaned passenger
- **Reserve Funds:** O&M Increase from 2 to 3 months over four years; R&R Increase from \$5M to \$10M over four years
- Amortization (Cash funded projects): Included in rates up to \$1M; 3% annual escalator; \$50M floor
- Reliever Airport Contribution: \$500,000 in FY4; 3% annual escalator
- Capital Improvements: Airfield only; Negative Majority-in-Interest (MII); Projects < \$2M exempted
- Gates: Preferential Use: 6 daily turns or 900 aircraft scheduled seats At Risk Gate: Can be taken back by MNAA with 30-day notice Reserved Common Use Gates: Reserve estimated 5 gates



Staff Recommendation

- New AULA meets MNAA's key goals and objectives:
 - 1) Allows implementation of BNA Vision, New Horizon, and other major projects to meet operational demand
 - 2) Increased aircraft gate utilization to use our assets more efficiently
 - 3) Maintains flexibility to accommodate changing needs/business models of all airlines serving BNA
 - 4) Maintains strong financial metrics debt service coverage, liquidity

Staff Recommendation:

Staff recommends the Board of Commissioners:

- 1) Approve the new Signatory Airline Use and Lease Agreement (AULA) and the Signatory Cargo Carrier Use Agreement, and
- 2) Authorize the Chair and President and CEO to execute these agreements with each Signatory Airline.

FY24 O&M and Capital Budgets – BNA, JWN and MPC

- On April 12, 2023, the Finance Committee reviewed in detail, and recommended approval of the 6 budgets by vote of 3 to 0.
- BNA budget based on FY24 moderate enplanement forecast (10.97M enplanements)
- FY24 budgets meet the President and CEO's guidance
 - Ensure we can make all required debt service payments
 - Meet both Board required debt service coverage and days cash on hand metrics to maintain our credit ratings
 - Minimize financial impact to our business partners to enhance future air service
 - Stay within the Official Statement's operating expense guideline for projected enplanement levels: \$165.3M
- Use of Federal Relief Grants (total award = \$126,452,218)
 - \$31.4M planned use in FY24
 - Balance of \$6.6M at 6/30/24 to be used in FY25








BNA – Revenues and Expenses YTD March 2023

Operating Revenues (\$ millions)




JWN – Revenues and Expenses YTD March 2023

Operating Revenues (\$ millions)




