


### **Donelson Pike Early Completion Incentive**

**Project Description:** Agreement with TDOT for MNAA to fund an incentive for Superior Construction Company Southeast LLC (Superior) to complete the relocation of Donelson Pike up to 365 days before the current contract completion date of May 31, 2026, and to allow Superior to borrow 200,000 CY NTE of fill material.

#### **Incentive Terms:**

- Completion date: May 31, 2025 (365 days early), with SR-255 switchover anticipated by April 15, 2025 (411 days early)
- Advance incentive of \$300,000/month, August 2024 May 2025
  - \$300K x 10 months = \$3,000,000 advance incentive
- \$3M bonus if complete by May 31, 2025
  - \$3M + \$3M = \$6,000,000 total incentive
- Bonus reduced by \$62,500/day after May 31, 2025, until total incentive exhausted
- Liquidated damages specified in TDOT's contract begin if work is not completed by September 4, 2025, instead of May 2026 as in current contract (\$4K/day)
- Superior will be permitted to borrow up to 200,000 CY of fill material from MNAA's stockpile sites to expedite the construction and will replace the fill material after completion of the Donelson Pike project

 Board of Commissioners authorize the President and CEO to execute an agreement with Tennessee

### FY24 O&M and Capital Budget Amendments – BNA and JWN

- On March 13, 2024, the Finance Committee reviewed in detail, and recommended approval of the 3 budgets by vote of 3 to 0.
- BNA adjustments driven by new passenger forecast for FY24 (23.48M forecast; 23.6M 23.8M projected)
- Key changes to FY24 BNA O&M Budget
  - Increased concessions, space rent and landing fee revenue
  - Increased expenses for parking lot operations, concessions, travel/training and conference sponsorship
  - Snow removal contractual services and supplies
- Key changes to FY24 Capital Improvements Budget are due to project bids and timing/scope of projects
- Key changes to FY24 JWN O&M Budget
  - Increased revenue for execution of three leases (5 parcels)
  - Increased expenses for studies, equipment/hangar repairs and administration/maintenance building set-up
  - Snow removal overtime and supplies



- Feb 17, 2021: Business Model approved
  - Direct Costs + Operating Costs + ROI = Total Rent
  - <u>Annual review</u> of operating expenditures & CPI-U escalation
- July 2021 June 2022: Base Rent established
- July 2022 June 2023: No Rent Increase Pandemic & On-going development
- July 2023 June 2024 (New rent equated to average 9.5% increase)
- FY25 Financial Analysis Conducted by Staff
  - New rent equates to average 7.2%
    - Average increase in monthly rent = \$62 (\$45 for non-box hangars)
  - March 20, 2024: Tenants will be notified of new rent effective July 1, 2024, to June 30, 2025.






#### **BNA** – Revenues and Expenses YTD February 2024

**Operating Revenues** (\$ millions)




#### JWN – Revenues and Expenses YTD February 2024


