



REAL ID FULL ENFORCEMENT

Acceptable Forms of ID (AFOID)

- U.S. Passport/U.S. Passport Card
- DHS Trusted Traveler Card (Global Entry, NEXUS, Secure Electronic Network for Traveler Rapid Inspection (SENTRI), Free and Secure Trade (FAST)
- U.S. Department of Defense (DOD) ID (active duty, retired, dependents, DOD civilians and and DOD CACs)
- Permanent resident card
- Border crossing card
- Native American Tribal Photo ID, issued by a federally recognized Tribal Nation/ Indian Tribe, including Enhanced Tribal Cards (ETCs)
- Homeland Security Presidential Directive 12 (HSPD-12) PIV card (PIV cards from all U.S. Government agencies)
- Foreign Government-issued passport
- Canadian Province Driver's License or Indian and Northern Affairs Canada (INAC) card
- Transportation Worker Identification Credential (TWIC) Congressional Member IDs (including spouse IDs)
- Airport/Aircraft Operator IDs
- Prison IDs (State and Federal; includes name, phone and date of birth)
- United Nations Laissez-Passer Passports
- DHS Refugee Travel Document (I-571)
- Department of Homeland Security (DHS) Re-enter the United States (I-327)


Note: TSA currently accepts expired IDs up to two years after expiration, for the above listed forms of identification.

- All airline passengers 18 years of age and older must present **REAL ID compliant identification or another Acceptable Form of ID (AFOID)** at TSA security checkpoints.
- **REAL ID only applies to state-issued IDs and Driver's Licenses.**
 - **REAL ID symbols include Gold Star, Black Star, Star Cutout in a gold circle, Star Cutout in a black circle, and a Star Cutout in a gold grizzly bear.**
 - **A temporary driver's license is not an acceptable form of identification.**
- **Enhanced Driver's License (EDL) or Enhanced IDs (EID)** are considered **REAL ID** and marked with "Enhanced" or "Enhanced Driver's License."
- **Digital IDs or Mobile Drivers Licenses (mDL)** are accepted at TSA checkpoints via state-issued app, or Google or Apple wallet.
- **Beginning February 1, 2026, all travelers without an acceptable ID, including those who present a non-REAL ID-compliant state driver's license or ID, will be referred to the optional TSA ConfirmID process for identity verification.**
 - **A fee of \$45 will be charged to each passenger who chooses to participate.**
 - **Travelers will be able to access by visiting tsa.gov and following the provided instructions to verify their identity.**
 - **The identification process takes an average of 10-15 minutes; however, it could take 30 minutes or more.**

- Dept. of State (DOS) issued Diplomatic Tax Exemption Cards
- FAA Credentials
